- All exhibitors must restrict their exhibit to the business registered with the Mt. Zion Chamber of Commerce. All multiple businesses that are Chamber members, must register each business they wish to exhibit.
- Doors will be open for setup on Friday, March 31, 2023 at 9:00 a.m. to 5:00 p.m.

All exhibitors are to be set up by 5:00 p.m.

- Exhibitors will unload in the front and park to the immediate north & east of the Convention Center on April 1, 2023.
- Exhibitors will **NOT** remove their display before 2:00 p.m. on Saturday, April 1, 2023.
